## Housing Killer Bills SB & AB 130

Dear Members,

We are issuing an urgent advocacy alert at the request of CBIA regarding the recent Vehicle Miles Traveled (VMT) legislation included in the Governor's budget, specifically AB 130 and SB 130.

This legislation is poised to become a massive new housing killer legislation imposing "economically impossible and legally flawed burdens" on new housing.

This policy is based on no sound economic data, with experts describing the state's VMT targets as a "fairy tale" that is unachievable. For some approved housing sites, the VMT mitigation cost could reach \$2 million per unit.

Given this severe threat to housing production across California, stopping or amending these legislative aspects is now a top priority. We are launching a full advocacy alert to engage our membership through multiple campaign efforts.

Your engagement is crucial.

These bills may be heard **as early as tomorrow, June 27** — and we need every BIASC member to make their voice heard now.
